

**THE 19 CRIMES X UFC INSTANT WIN PROMOTION
OFFICIAL RULES**

OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE AT LEAST 21 YEARS OLD AT THE TIME OF ENTRY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW, INCLUDING PUERTO RICO AND ALL U.S. TERRITORIES AND POSSESSIONS.

- PROMOTION PERIOD:** The Promotion has two (2) components: An Instant Win Game (the “**Instant Win Game**”) and a Random Draw Sweepstakes (“**Sweepstakes**”). Instant Win Game and Sweepstakes are collectively referred to herein as the “**Promotion**”. Administrator’s computer is the Promotion official clock.

The Promotion begins at 12:00:00 AM Pacific Time (“**PT**”) on Wednesday, January 1, 2025 and ends at 11:59:59 PM PT on Wednesday, December 31, 2025 (the “**Promotion Period**”). Within the Promotion Period, there are four (4) Sweepstakes Entry Periods (each, a “**Sweepstakes Entry Period**”) as defined in the “**Sweepstakes Entry Periods and Random Drawings Schedule**” below. Entries must be received during a Sweepstakes Entry Period to be eligible for that Sweepstakes Entry Period’s Sweepstakes prizes.

- ELIGIBILITY.** The Promotion is offered only to legal residents of the 50 United States and the District of Columbia who are at least 21 years of age at the time of entry (“**Entrant**”). Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and

each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “**Promotion Entities**”), and each of their immediate family members (e.g., spouse, parent, sibling, child, and their respective spouses and the “steps” of each, all lineal descendants, including those by adoption, regardless of where they reside) and persons living in the same household of each, whether or not related, state alcoholic beverage manufacturers, distributors, and retailers and the employees and immediate family members (as defined above) of manufacturers, distributors and retailers, employees of state or local alcohol beverage agencies are not eligible to enter or win. Participation constitutes Entrant’s full and unconditional agreement to these Official Rules and Sponsor and Administrator’s decisions and interpretations, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. If an Entrant participates via a mobile device, message and data rates may apply. Not all cellular phone providers carry the service necessary to participate in this Promotion through a mobile device. If entering using a mobile device, please check your mobile device’s capabilities for specific web enabled browsing instructions and pricing plans. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. Promotion is subject to all applicable federal, state and local laws and regulations. Sponsor reserves the right to verify eligibility of winners.

- 3. HOW TO ENTER THE PROMOTION:** To enter both the Instant Win Game and Sweepstakes, during the Promotion Period, visit www.19crimes.com/UFC (the “**Promotion Site**”), follow all instructions to complete the registration form in its entirety, and submit the form. After submitting the form, follow the instructions to play the Instant Win Game. By filling out the registration form in its entirety and submitting it pursuant to the instructions on the Promotion Site you will receive one (1) Instant Win Game play (“**Game Entry**”) one (1) Sweepstakes Entry (“**Sweepstakes Entry**”). Each day thereafter, for the remainder of the Promotion Period, you will be able to return to the Promotion Site, complete the registration form in its entirety, submit the form to receive one (1) additional Game Entry and one (1) additional Sweepstakes Entry. **Limit: One (1) Game Entry and one (1) Sweepstakes Entry per Entrant per day.**

Any additional entries and/or plays will be void and ineligible. For the purposes of this Promotion, a “day” is defined as the twenty-four (24) hour period commencing at 12:00:00 AM PT, and ending at 11:59:59 PM PT. Although the Sponsor and/or Administrator may receive a participant’s subsequent attempts to enter on a given day, only the first complete Sweepstakes Entry and Game Entry received from a particular Entrant on that day will be eligible; subsequent attempts by the same Entrant to enter/play during that same day, including entries/plays submitted with an alternate email address, will be disqualified. 4. PRIZES AND ODDS OF WINNING: The total Approximate Retail Value (“ARV”) of all prizes available to be won in connection with this Promotion: **\$15,103.80**. It is possible for an Instant Win Prize winner to also win a Sweepstakes Prize. **No Alcohol Beverages are included in any prize.**

a. Instant Win Game Prizes: There are 180 Instant Win Game Prizes (each, an “Instant Win Prize”) available to be won during the Promotion Period consisting of the Instant Win Prizes listed in the chart below. **The total ARV of all Instant Win Prizes available to be won in the Promotion: \$5,803.80. Limit: One (1) Instant Win Prize per family or household.** Odds of winning an Instant Win Prize are dependent on the random winning time selected for each Instant Win Prize available to be won, the number of participants in the Promotion, and the time and order any Entrant’s Game Entry is submitted and recorded. b. Sweepstakes Prizes: There are sixty-one (61) Sweepstakes Prizes (collectively, the “Sweepstakes Prizes”) available to be won during the Promotion Period, consisting of the sixty (60) First Prizes (each, a “First Prize”) and one (1) Grand Prize (the “Grand Prize”) as described below. **The total ARV of all Sweepstakes Prizes available to be won in the Promotion: \$9,300. Limit: One (1) First Prize per family or household.** Odds of winning a Sweepstakes Prize are determined by the number of eligible Sweepstakes Entries received during each Sweepstakes Entry Period.

- **Sweepstakes Entry Period #2:** The following prizes will be awarded for Sweepstakes Entry Period #2: Twenty (20) First Prize winners will each receive one (1) Pay-Per-View

Code that can be used toward the purchase of one (1) UFC event of Sponsor's choice. The ARV of each First Prize is \$80.00.

- **Sweepstakes Entry Period #3:** The following prizes will be awarded for Sweepstakes Entry Period #3: Twenty (20) First Prize winners will each receive one (1) Pay-Per-View Code that can be used toward the purchase of one (1) UFC event of Sponsor's choice. The ARV of each First Prize is \$80.00.
- **Sweepstakes Entry Period #4:** The following prize will be awarded for Sweepstakes Entry Period #4: One (1) Grand Prize winner will receive a trip package for two (2) people, Grand Prize winner and one (1) guest, to a UFC event scheduled to take place on a to-be-determined date during the 2026 calendar year at a to-be-determined location within the 50 United States ("**UFC Event**"). The UFC Event, date, location and seating arrangements will be determined by the Sponsor in its sole discretion. The ARV of the Grand Prize is \$4,500. Grand Prize trip package includes:
 - i. Round-trip, coach-class air-transportation for Grand Prize winner and one (1) guest to a to-be-determined by the Sponsor location within the 50 United States;
 - ii. Three (3) days and two (2) nights hotel accommodations, based on single room with double occupancy;
 - iii. Two (2) tickets to the UFC Event; and
 - iv. \$1,000 cash allowance, to be awarded in the form of a check or pre-paid bank gift card.

- 5. PRIZE CONDITIONS:** Instant Win Prizes and Sweepstakes Prizes are not redeemable for cash, assignable, transferable and may not be substituted except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value at its discretion. Any difference between the stated value and actual value of any prize will not be awarded. Any other incidental expenses on a prize not specified herein are the winner's sole responsibility. Sponsor will not replace any lost or stolen prizes or components of a prize(s). Only the number of prizes stated in these Official Rules is available to be won in the Promotion. If, by reason of a print or other error, more prizes are claimed than the number set forth in these Official Rules, winners will be determined in a random drawing from among all eligible claimants making purportedly valid claims to award the advertised number of prizes available.

Prizes are awarded "as is" with no warranty or guarantee, either express or implied by Sponsor. Winners acknowledge that the Promotion Entities and their agents do not make, nor are in any manner responsible for any warranty, representations, expressed or implied, in fact or in law, relative to the quality, conditions, fitness or merchantability of any aspect of any prize being offered, except that each merchandise prize shall be subject to its manufacturer's standard warranty (if any). The specifics of a prize model, color and size awarded shall be solely determined by the Sponsor. Actual prizes awarded may vary from that depicted in advertising materials. Winners are responsible for all federal, state, local and income taxes associated with winning any prize.

Instant Win Prize Exclusions and Conditions: Instant Win Prizes will be mailed to the winner's mailing address provided at the time of Entry. The Promotion Entities shall not be liable for any mistake made by prize winners or shipping fulfillment providers in shipment or delivery of

any prize. Once a prize has been delivered to winner's provided mailing address the prize is considered awarded.

First Prize Exclusions and Conditions: First Prizes will be awarded as a code emailed to the winner's email address provided at the time of Entry or new email address provided at the time of notification by the Administrator, as further described below. First Prizes will not be replaced if lost or stolen and are subject to the issuing company's complete terms and conditions, including expiration dates.

Grand Prize Travel/Accommodation/Event Exclusions and Conditions: The ARV of the Grand Prize may vary based upon dates of travel and point of departure. Sponsor shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the air carriers, hotels, venue operators, transportation companies, prize providers or any other persons providing any prize-related services or accommodations. Sponsor is not liable for expenses incurred as a consequence of flight cancellation/delay. No refund or compensation will be made in the event of the cancellation or delay of any transportation or other prize element except at the sole and absolute discretion of Sponsor. Travel is subject to the terms and conditions set forth in these Official Rules, and those set forth by airline carrier as detailed in the passenger ticket contract. The passenger contracts in use by the airline or other transportation companies shall constitute the sole contracts with respect to the Grand Prize Winner's and Guest's transportation and such contracts shall be solely between the Grand Prize Winner, Guest and such transportation companies. Trip components issued in connection with the Grand Prize may not be eligible for frequent flyer miles, other rewards programs or upgrades. unable to travel after all travel arrangements have been made and paid, the Sponsor shall have no further obligation to the Grand Prize Winner.

The Sponsor and Zuffa LLC not liable for any loss or penalties incurred if the UFC Event is sold, ceases to exist, or becomes inoperative; if the UFC Event is delayed, postponed, cancelled or changed for any reason; for acts of nature; or for amenities, services and/or facilities not being available due to renovations, strikes, bankruptcy, public health pandemic and/or acts of God or nature. Event tickets are issued subject to terms and conditions of the issuing company. Event tickets will not be replaced if lost or stolen. In the case of Event cancellation, mechanical difficulties, acts of God, equipment unavailability, celebrity or athlete illness or the like, Sponsor reserves the right to make a reasonable substitution. If substitution is not possible, Sponsor reserves the right to cancel on short notice. If the UFC Event is delayed, postponed, cancelled or changed by Sponsor or a third party, or for any reason, Grand Prize Winner will be notified as soon as possible. If it is not possible to substitute with an alternative date, Sponsor may cancel or provide a reasonable substitute of equivalent or greater value. Notwithstanding anything to the contrary in these Official Rules or otherwise, Sponsor and Zuffa LLC will not offer cash substitution or refunds or be liable in any way for expenses that the Grand Prize Winner may incur related to the UFC Event or prize component that has been cancelled, except in their sole and absolute discretion. Grand Prize Winner and Guest acknowledge that the terms and conditions printed on and otherwise applicable to ticketholders for the UFC Event or persons present at the venue in question govern their presence at the UFC Event/venue.

In the event Grand Prize Winner and/or Guest engages in behavior that, as determined by the Sponsor in their sole discretion, is obnoxious or threatening, illegal, that is intended to annoy, abuse, threaten or harass any other person, or that in any way disparages or adversely affects the reputation, image, and/or customer goodwill of Sponsor or any of their services, products, trademarks, service marks, or logos, Sponsor reserves the right to terminate the trip early, in

whole or in part, and send the Grand Prize Winner and/or the Guest home with no further obligation or compensation whatsoever to Grand Prize Winner and Guest. In the event the Grand Prize Winner and/or Guest engages in behavior during travel that (as determined by Sponsor in its sole discretion) is illegal, tortious, or subjects Grand Prize Winner and/or Guest to arrest or detention, Sponsor shall have no obligation to pay any damages, fees, fines, judgments or other costs or expenses of any kind whatsoever incurred by Grand Prize Winner and/or Guest as a result of such conduct. SPONSOR AND ZUFFA LLC SHALL HAVE NO LIABILITY FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF ANY TRAVEL RELATED TO THE GRAND PRIZE OR ANY OTHER ASPECT OF GRAND PRIZE WINNER'S AND GUEST'S ACCEPTANCE OR USE OF THE PRIZE.

6. SELECTION OF WINNERS AND VERIFICATION OF WINNERS.

- a. **Instant Win Game Selection and Verification of Winners:** Instant Win Prizes will be awarded throughout the Promotion Period, pursuant to the process set forth herein. 180 random, computer-generated winning dates and times, one for each Instant Win Prize available to be won, will be generated by the Administrator prior to the state date of the Promotion Period. At the time an Entrant submits their first Game Entry and each time that same Entrant provides a subsequent, eligible Game Entry (subject to the requirements set forth above), if such Entrant is the first eligible Entrant to receive a Game Entry in connection with the Instant Win Game at or after a computer-generated, randomly selected winning time, that Entrant will receive an on-screen notification alerting them that they are a potential winner of an Instant Win Prize*. Non-winning entrants will also be notified on screen. *A resident of New Jersey will not receive an on-screen notification, but will receive a notification via email within approximately forty-eight (48) hours if they are a potential winner of an Instant Win Prize (the "**New Jersey Notification**").

Potential Instant Win Prize winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements in these Official Rules. All winning claims are subject to verification by the Administrator and/or Sponsor, whose decisions are binding. Even if the Instant Win Game, an email notification or New Jersey Notification shows that you are a winner, you are not a winner until your eligibility and the potential winning Game Entry have been verified.

In the event that a potential Instant Win Prize winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate Instant Win Prize winner selected by a random drawing from among all remaining eligible entries. Only one (1) alternate drawing will be held, after which any remaining Instant Win Prizes will remain un-awarded. If Sponsor fails to receive a sufficient number of Game Entries to correspond to the number of Instant Win Prizes available to be awarded, Sponsor reserves the right to not award such prize(s).

Within 60 days of an Instant Win Prize winner's verification, the Instant Win Prize will be mailed to the winner's mailing address provided on the registration form at the time of entry. Sponsor will not replace any lost or stolen prizes or components of a prize(s). If an

Instant Win Prize is returned as undeliverable, that winner will be disqualified and winner's claim on the prize is void.

- b. Sweepstakes Selection and Verification of Winners:** The potential Sweepstakes Prize winners will be selected in a series of random drawings from among all eligible Sweepstakes Entries received within the corresponding Sweepstakes Entry Period on or about the corresponding Random Drawing Date included in the Sweepstakes Entry Period & Drawings Schedule in the "Promotion Period" section of these Official Rules. Random Drawings will be conducted by the Administrator, an independent representative of the Sponsor, whose decisions are final. Sweepstakes Prize winners are deemed to be potential winners, pending verification of Entrant's eligibility and compliance with these Official Rules, as determined by the Sponsor or Administrator, in their sole and absolute discretion. If Sponsor is unable to determine and verify a Sweepstakes Prize winner after repeated alternate drawings, Sponsor reserves the right to not award such prize(s).

First Prize Winners: Potential First Prize winners will be notified by the Administrator via email and will be required to confirm their name, address, date of birth and the email address where they would like their prize delivered, within two (2) days via return email. Noncompliance, ineligibility, failure to respond to notification, or undeliverable email, will result in disqualification and an alternate winner may be selected.

Grand Prize Winner: The potential Grand Prize Winner will be notified by the Administrator via email and/or phone, and will be required to sign and return, within five (5) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These Releases will require the Grand Prize Winner to furnish their Social Security Number for the sole purpose of tax reporting, as required by law. Grand Prize Winner's Guest will also be required to sign a Travel Companion Liability & Publicity Release. Noncompliance, ineligibility, failure to respond to notification, or undeliverable email or phone notification, will result in disqualification and an alternate winner may be selected.

Sweepstakes Entries, Game Entries, e-mail notifications, electronic messages, or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic, or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, programming, printing, typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction, or unauthorized access to the Promotion; (vii) any injury or damage, whether personal or property, to Entrant or to any person's computer related to or resulting from participating in the Promotion and/or accepting a prize; or (viii) Sweepstakes Entries and/or Game Entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Released Parties are not responsible for any unanswered or undeliverable winner notifications.
