

## THE CARQUEST WORLD FINALS SWEEPSTAKES OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** The **CARQUEST World Finals Sweepstakes** (the "Sweepstakes") is open to legal residents of the 48 contiguous United States, including the District of Columbia, who are age 18 or older and the age of majority in their state of residence (19 or older in Alabama and Nebraska; 21 or older in Mississippi) at the time of entry. Void in Alaska, Hawaii, Puerto Rico, Guam, the U.S. Virgin Islands, all other US territories and possessions, outside the 48 contiguous U.S./D.C. and wherever else prohibited by law. Employees of Advance Stores Company, Incorporated (the "Sponsor"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator") and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Entries must be received **between Wednesday, May 10, 2023 at 12:00:01 AM ET and Saturday, September 30, 2023 at 11:59:59 PM ET**. Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy, which can be found at <https://shop.advanceautoparts.com/o/privacypolicy>.

**Limit: One (1) Entry per person per day regardless of whether entrant has more than one email address.** All Entries become the property of the Sponsor and will not be acknowledged or returned. Although subsequent attempts to enter on a given day may be received, only the first complete Entry received from a particular entrant will be eligible; subsequent attempts by the same person to enter, including entries submitted with an alternate email address, will be disqualified.

**PRIZE/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:** There is one (1) "Grand Prize" (as defined below) available to be won. One (1) Grand Prize winner ("Winner") will receive a trip package for two (2) people, Winner and one (1) guest (the "Guest"), to attend the World of Outlaws® World Finals in Concord, North Carolina (the "Grand Prize"). Grand Prize trip package includes:

- Round-trip, coach-class air-transportation for Winner and Guest to Charlotte, North Carolina from a major airport within the 48 contiguous United States nearest the winner's residence as determined by Sponsor;
- Five (5) nights hotel accommodations based on a single room with double occupancy at

- Two (2) passes to the World of Outlaws World Finals for November 1, 2023 through November 4, 2023;

Winner's Guest must be a must be a legal U.S. resident, 18 years or older and the age of majority in their state of residence, unless Guest is a child of the winner. Guest must complete and return a Travel Companion Liability & Publicity Release (as defined below) prior to travel as noted below. If winner's Guest is deemed a minor in their state of primary residence, Winner must be minor Guest's parent or legal guardian and must execute the Travel Companion Liability & Publicity Release on the minor Guest's behalf, as applicable.

**RANDOM DRAWING:** The potential winner will be selected in a random drawing on or about **Monday, October 2, 2023** from among all eligible entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

**WINNER NOTIFICATION & VERIFICATION:** The potential winner will be notified via email and/or phone, and will be required to sign and return, within three (3) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). Guest of Winner will also be required to sign a Liability Waiver and Publicity Release (collectively the "Travel Companion Liability & Publicity Release"). Noncompliance will result in disqualification and an alternate winner may be selected.
