

**NATUROPATH TO PRACTICE AWARDS SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

**ELIGIBILITY: NaturoPath To Practice Awards** (the “Sweepstakes”) is not open to the general public. Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia and Puerto Rico (collectively for this Sweepstakes, the “Territory”) who: (1) are age 18 or older and the age of majority in their state/territory of residence (19 and older in Alabama and Nebraska; 21 and older in Mississippi and Puerto Rico) at the time of entry; and (2) are enrolled at a naturopathic college/university at the time of entry or graduated from a naturopathic college/university no more than 6 months before the time of entry. **HOW TO ENTER: Online Entry.** During the Sweepstakes Period, visit <https://binkd.co/eGmijk> and follow all entry instructions to complete the entry form and submit to receive one (1) entry into the Sweepstakes (the “Online Entry”). **Entries must be received in accordance with the Entry**

**PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:**

**Grand Prize:** There are twenty (20) Grand Prizes available to be won, five (5) per Entry Period. Each Grand Prize is one (1) \$500 check that may be used toward the cost of board examinations and will be awarded in the name of the confirmed winner.

**The ARV of Grand Prize: \$500 each. The total ARV of all Grand Prizes per Entry Period: \$2,500.**

**The total ARV of all prizes available to be won: \$10,000.**

**DISPUTES:** The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Polk County, Iowa and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Polk County, Iowa. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Polk County, Iowa. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing).
